
Use of ProceedsThe Bonds are being issued to refund certain outstanding obligations of the Issuer.


Bond Security

The principal of and interest on all State general obligation bonds, including the Bonds, are payable from any moneys in the General Fund of the State, subject under State law only to the prior application of such moneys to the support of the public school system and public institutions of higher education.






